Hill Visit Availability

In conjunction with the AHTCC Spring Meeting and 14th Annual Charles L. Edson Tax Credit Excellence Awards we will be scheduling Hill Visits with key Members of Congress. Don't miss this opportunity to remind Congress that the affordable housing industry supports Low Income Housing Tax Credit modernization NOW!

Several pieces of housing related legislation are currently working their way through Congress. Most important, Senate bill S. 2666, *The Affordable Housing Investment Act of 2008*, and House bill H.R. 5720, *The Affordable Housing Tax Act of 2008*, contain important Low Income Housing Tax Credit (Housing Credit) provisions which, if enacted, will simplify the program and allow for greater flexibility, efficiency, and preservation opportunities. Provisions such as allowing Housing Credits to offset alternative minimum tax liability and repealing the recapture bond provision will ensure the Housing Credit program remains a meaningful investment opportunity in the current economic climate.

Getting the bills introduced is only half the battle. It is important now, more than ever, that Congress hear from you, the Housing Credit community. Hill Visits are an important part of the legislative process. Never participated in Hill Visits? The Coalition will prepare you for your visits during the Spring Meeting and provide all necessary materials. We will also pair newcomers up with seasoned veterans or Coalition representatives.
